

2021-2022 ADMISSION REQUIREMENTS FOR NORTH CADDO MAGNET HIGH SCHOOL

COMPLETING THE APPLICATION

Incoming 9th grade students will be registered and scheduled for the 2021-2022 school year after the following two items are checked by the school:

- BASIC or higher on the ELA and mathematics sections of the LEAP 2025 from spring testing in 8th grade, which will be checked electronically for current Caddo Parish public school students.
- Final report card for the current school year, which will be checked electronically for current Caddo Parish students.

All students NEW to NC must submit the following:

- Most recent standardized test scores with a bar graph or national percentile ranking (NPR)
- Most recent report card with a GPA
- Printed attendance and discipline record (from the Student Progress Center JCampus)

<u>BRAND NEW Students enrolling in Caddo Parish for the FIRST time must submit enrollment documentation through the Caddo Attendance Department.</u> www.caddoschools.org

*According to Caddo Parish policy, any student entering the 9th grade that is transferring to any public school from an in-state non-public school, or home schooling program, or Louisiana resident transferring from any out-of-state school, shall be **required** to pass the English Language Arts and Mathematics portions of the state authorized placement test. More information on this test can be obtained at the Caddo Parish School Board. The application is considered **incomplete** until the assessment results are received by the registrar.

Phasing: We take special care in placing students in the appropriate classes whenever possible in order to create a challenging and rigorous educational experience that enables every student to be academically competitive. The following criteria is what we will follow for initial placement. Phasing placement can change from year to year based on the standardized test for that year.

Honors: PSAT 8/9 Composite Score ≥ 1100; ACT Score ≥ 18; and/or LEAP Scores of at least MASTERY **Enriched:** PSAT 8/9 Composite Score ≥ 980; ACT Score ranging from 15-17; and/or LEAP Scores of at least BASIC

NC BEST MAGNET APPLICANTS

For admission into the NC BEST magnet, each applicant must have the following:

- A 2.75 or higher cumulative grade point average on the most recent report card.
- A score of 750 or higher on the LEAP Math and ELA.
- A school attendance record of 95% or better (Students must be present at school for 95% of all school days. Unexcused absences will total no more than 5% of school days; minimal tardies are reviewed.)
- An exemplary school discipline record. (No out-of-school suspensions; minimal detentions and in-school suspensions will be carefully reviewed.)

For conditional admission, applicants must have the following:

- A 2.5-2.74 grade point average on the most recent report card.
- A score of 730 on the LEAP Math and ELA
- A school attendance record of 95% or better (Students must be present at school for 95% of all school days. Unexcused absences will total no more than 5% of school days; minimal tardies are reviewed.)
- An exemplary school discipline record. (No out-of-school suspensions; minimal detentions and in-school suspensions will be carefully reviewed.)
- We reserve the right to ask for letters of recommendation from **current** teachers

Students applying for the NC BEST Magnet in grades 10 and above must also submit the following:

- Complete record of grades earned for high school credit (the most current transcript) indicating a cumulative GPA of at least 2.5 on a
 weighted scale.
- LEAP Assessment results, scoring **Basic or higher** on any exams the student has taken OR a review of testing history including ACT/PSAT/SAT will be done for *conditional admissions*.
- Results from any standardized test (ACT, PSAT, Explore, Plan, etc) that the student has taken should also be submitted.
- Incoming seniors requesting transfer to North Caddo should have an ACT of 17 or higher.
